The Corvallis Police Department is charged with issuing amplified sound permits in accordance with Corvallis Municipal Ordinance 5.03.030.030. As per CMO 8.03.100.070 the fee applicable to a sound permit is \$5 per day; payment is required at the time the application is submitted for processing. Applications not submitted at least seven days prior to the event will be rejected.

**CORVALLIS POLICE DEPARTMENT
AMPLIFIED SOUND PERMIT CONDITIONS**

To insure the residents of Corvallis are not unduly disturbed by amplified sound, the following noted conditions are in effect with this permit. You, the applicant, are the responsible person as noted below.

Read and initial each item below:

1. _____ The responsible person shall turn down or terminate all amplified sound upon citizen complaint at the direction of any police officer.
2. _____ The responsible person be available during the event and cooperate with police.
3. _____ You/your organization will notify surrounding neighbors of the event and furnish those neighbors with your name and telephone number with instructions to call should they have a complaint. Telephone complaints must be responded to and appropriate corrective action taken.
4. _____ You must provide security so participants in your event do not gather on the surrounding streets thereby impeding traffic. Security can either be designated persons from your organization, assigned volunteers, or hired security agents.
5. _____ All amplified sound must stop by 11:00pm.
6. _____ Police response may result in enforcement action including arrest, citation, and/or issuance of a Special Response Fee Notice to the responsible person.
7. _____ Additional response to any disturbance after the issuance of a Special Response Fee Notice will result in a significant civil penalty in addition to any additional arrest(s) or citation(s) to the responsible person.
8. _____ A valid noise complaint may result in automatic disapproval of any other sound permits for a period of at least one year from the date of the initial complaint.
9. _____ An OLCC Temporary License will be needed if any alcoholic beverages are to be served.

I am aware of the above listed permit conditions and agree to abide by them.

Upon approval of the permit I understand any additional conditions listed shall be followed, and failure to do so will result in the immediate revocation of the permit.

I understand I must retrieve a copy of the permit upon approval and have it available for presentation to any police officer requesting it during the event.
